“The Korean War and the Relevance to Current Political Issues”

In the summer of 1950, in the midst of a political crisis here at home, and surrounded by dangerous threats to our national security abroad, the United States found itself confronted by an invasion half a world away. The resulting war in Korea brought to light many of the issues that continue to divide our politics today. The Korean

War forced Americans to question our leadership role on the world stage, forced the United States to reexamine its relationship with China and the Far East, and forced the nation to address issues of Presidential power and military control. With continued tension on the Korean peninsula today, the Korean War remains a pivotal turning point moment in modern American history.
