INFORMATION CONCERNING CONFIDENTIALITY

However, once reported, the College has an obligation to address discrimination, harassment and sexual misconduct and, in order to conduct an effective investigation, complete confidentiality cannot be guaranteed. REPORTING SEXUAL MISCONDUCT

Sexual misconduct is a form of sex discrimination strictly prohibited by Title IX. Sexual misconduct includes dating violence, domestic violence, stalking, sexual assault and sexual harassment, as defined in TBR policy 6.03.00.00 Sexual Misconduct.

To the College: If you believe you have been sexually assaulted or stalked or are a victim of dating or domestic violence, you are encouraged to report the occurrence to the College's Title IX Coordinator so the College may initiate and pursue an investigation of the event. If you wish to report an incident of sexual misconduct in a confidential manner, a list of available community resources may be obtained from the Advising Center or by calling 615-230-3702. If you choose to report the incident in a confidential manner, the College may be unable to conduct an investigation into the matter or pursue disciplinary action against the alleged offender.

To law enforcement: If you would like to report the incident directly to law enforcement for criminal investigation, please call the Campus Police Department at 615-230-3595, your local enforcement office or dial 911 if you need emergency assistance. The College will not share information with law enforcement without your consent.
