

Medical Laboratory Technology Licensure Disclosure

Licensure requirements for medical laboratory technologists (MLT) vary according to state statutes. Graduates of Volunteer State Community College's MLT program are eligible to sit for the national certification examination.

The State Licensing column will indicate:

- **Meets**- the Vol State program curriculum meets requirements in these states and US Territories
- **Does Not Meet**- the Vol State program curriculum does not meet the requirements in these states and US Territories
- **None** – there are no known requirements for licensing in these states and US Territories
