

Physical Therapist Assistant Licensure Disclosure

Volunteer State Community College’s graduates of the Physical Therapist Assistant Program are eligible to apply for state licensure in any U.S. jurisdiction and, upon approval by the applicable licensing board, may sit for the National Physical Therapy Examination administered by the Federation of State Boards of Physical Therapy (FSBPT).

The State Licensing column will indicate:

- **Meets**- the Vol State program curriculum meets requirements in these states and US Territories
- **Does Not Meet**- the Vol State program curriculum does not meet the requirements in these states and US Territories
- **None** – there are no known requirements for licensing in these states and US Territories
- **Undetermined** - the Vol State program curriculum has yet been determined if the curriculum meets the requirements in these states and US Territories.
